

**PUBLIC WATER SUPPLY DISTRICT #1 OF PUTNAM COUNTY, MISSOURI**

**WATER USER'S AGREEMENT**

The undersigned, being the owner or occupier of land located within the above Public Water Supply District, hereby makes application to said District for \_\_\_\_\_ water service connection(s), and if water service is made available by said District, agrees to the following conditions:

1. To become a water user of the District, and I hereby tender a sum of \$\_\_\_\_\_ to be added to any prior deposit for water service connection(s).

2. Pay a minimum monthly meter charge of \$\_\_\_\_\_ per month for 1,000 gallons of water for the water service connection from time service is made available by the District, and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum monthly water charge and rate schedule by the Board of Directors of the District shall become a part of this agreement as though fully set out herein.

3. The Rules and Regulations of the District provide that water users will remit the payment of the month's water bill no later than the 10th day of the month. Bills not paid on the 10th day of the month shall be subject to a 10% late charge. Failure to pay before the disconnect date located under messages on the monthly water bill shall result in discontinuance of the service.

4. The water service supplied by the District shall be for the sole use of the undersigned; the undersigned agrees that he or she will not extend or permit the extension of pipes for the purpose of transferring water from one property to another, nor will he or she share, resell, or sub-meter water to any other consumer. Each meter service shall supply water to only one (1) residence or business establishment located on land within the District.

5. If after water service is made available, the same is discontinued or disconnected for any purpose, pursuant to the By-laws and the Rules and Regulations of the District, reconnection shall be upon the conditions set out by the By-laws and the Rules and Regulations of the District.

6. The undersigned agrees that he or she will make no physical connection between any private water system and the water system of the District. Representatives of the District may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision. Violation of this provision shall be grounds for disconnection of service.

7. The laws of the State of Missouri, the By-laws of the District, and the Rules and Regulations of the District, as presently existing, and as may be amended from time to time, are made a part of this agreement as though fully set out herein.

8. The undersigned agrees that he will grant a water line easement to the District for the transmission of water over, under and across any interest he may have in real property bounding the roads along which the initial water transmission lines of the District are planned in consideration for the District accepting this application.

9. The location or description of the property to be served by the water service connection is: (Set forth the legal description of the property or the address and location thereof).
